Dear Mr. Gonzalez

I, the undersigned, CERTIFY UNDER PENALTY OF PERJURY that I am the owner or an agent authorized to act on behalf of the owner of certain intellectual property rights, said owner being named Ordo Templi Orientis (a nonprofit California corporation) ("IP Owner").
